PLEASE READ THESE TERMS OF USE CAREFULLY BEFORE USING THE SERVICE.

These Terms of Use (these "**Terms of Use**") set forth a legally binding agreement between you ("**Service Partner**" or "**You**") and SEIKO EPSON CORPORATION (including its subsidiaries and affiliates collectively referred to as "Epson") and govern your use of this Epson TechExchange System (the "**Service**").

By using the Service on any computer, tablet or other device (collectively "**Device**") you signify that you have read, understood and agree to be bound by these Terms of Use, and consent to the collection, use, and sharing of your data and other activities as described in our Privacy Policy described Section 11.1 of these Terms of Use. If you do not agree to these Terms of Use, please do not use the Service. Furthermore, if you use the Service continuously, you agree to be bound by these Terms of Use.

1. Purpose of the Services.

The purpose of the Service is to enable you to provide technical support services (including after support services, repair and/or modification of Epson's products) to Epson customers or your own customers (the "**Purpose**") by posting, publishing and providing the technical information as defined in Section 3.2 of Epson's products (the "**Technical Information**").

- 2. User Registration, User Maintenance, User ID and Password of the Service.
 - 2.1. User Registration.Epson may associate a user ID and an initial password in order for you to use the Service.
 - 2.2. Registration of your Information.When you register to use the Service, you agree to provide accurate and current information about yourself (for example; your electronic mail and your personal information. Collectively referred to as "Your Information").
 - 2.3. Safeguarding User ID and Password.You shall use and maintain your user ID and Password according to the following:

2.7. Notice.

2.9. Use of your registered information by Epson.Epson may use your registered information for the purpose of offering and

improvement of the Service or other services provided by Epson, even if you withdraw from the Service or your use is terminated or suspended.

2.10. Authorised Registration.

If you are registering or using the Service as an agent or on behalf of a company or other organization, you represent that you have authority to bind that agent, company or other organization to these Terms of Use.

3.1. Limited License.

8.1. Confidentiality Obligation.
